#### **DNR Report**

# Handicap Ped Ramps

Kent Skaar, DNR, then addressed the group regarding the issue of the Handicap Ped Ramps on mile 6, 7, & 8 of the trail between Pipestone and Woodstock. With all DNR projects, ADA requirements are paramount to each project and must be strictly adhered to. The location of the ped ramps is very specific. The ramp is to be placed at the edge of the road to indicate there is a change in the condition of the trail, not the surface. When the DNR purchased the abandoned railroad bed (Casey Jones State Trail), the Deed

reflects DNR owns the entire corridor including the corridor over the road. The DNR has met with the Burke Township Board twice and is working with Burke Township to help address any issues that could be encountered with maintenance of the road where the ped ramps are located.

## Surface Miles 9 & 10 and Six-Mile Currie Loop Trail

Discussion then followed on costs and funding to mill and overlay the Six-Mile Currie Loop trail and complete the three alternates to pave the last two miles to Woodstock, pave a small parking lot at the trailhead in Woodstock and make the entire 10-mile segment ADA accessible. Kent informed the Friends that DNR does not do mill and overlays on state trails but full trail reconstruction. Therefore, the loop trail would be a full reconstruction.

Michael Moges, SRDC, then gave the Board an update on the EDA CARES funds. Because of the requirements of creating and retaining jobs when using any EDA funding, it was felt the trail projects wouldn't qualify to receive the EDA CARES funding at this time.

It was the consensus of the Friends to have Kent and Chris present different funding options at the next meeting.
