## DNR Update

### Pipestone Trail Head Plan

Mick stressed that the plan is just a first draft and can be simplified if necessary. And he asked Chris to see what he can find out about the DNR's Community Roadside Landscaping Program. Ron stated that the parking lot needs a load of gravel.

#### **Drone Photos**

A drone is considered to be "aircraft" and a permit is required to land aircraft on DNR property. Chris I. will contact Terry Thone regarding applying for a permit.

#### Annual Meeting

The Annual Meeting will be June 7 at 2:30 p.m. at the Hiawatha Lodge in Pipestone. The meeting notice will state that a short program will follow the meeting and RSVPs are appreciated. Amy will mail and email invites to members.
