The Friends of the Casey Jones Trail Association convened in regular session in-person and via Zoom on March 17, 2022 at 11:30 a.m at the Slayton Pizza Ranch. #### APPROVE AGENDA

Motion was made by Dan, seconded by James and unanimously carried to approve the agenda.

#### APPROVE MINUTES

Motion was made by Dan, seconded by Myron and unanimously carried to approve the meeting minutes from the previous meeting.

## TREASURER AND MEMBERSHIP REPORT

Jakob reported that the friends have received \$183.94 in donations and membership since the last meeting in February. The only expense was \$96 to Amy Rucker for reimbursement of payment to renew our website. Jessica and Jakob have tried to figure out how to transfer the website credentials from Amy but it has been difficult. So far, Amy has not minded that we reimburse her once a year.

Jakob reported that he was invited to speak at the Shetek Area Lake Association about the Casey Jones Trail and Friends. The SALA became a Friends member at the Contributor level (\$50) after Jakob's presentation. Jakob requested that we reciprocate a membership to the SALA from the Friends. Motion was made by Jakob, seconded by Dan and unanimously carried to approve a membership at \$50 to the Shetek Area Lake Association.

There is a total of 35 members, which is down from 2021 (44).

#### **BUSINESS**

## Committee Updates

The Acquisition Committee met on March 2. They met with Kent Skaar and created a priority list. They will meet again in April. Stephanie Korver will take the maps that the club created last year and make them digital and editable. Kent provided characteristics of land that is most desirable and least cost effective to build trails.

The PR and Communications committee also met in March. They discussed acquiring trail user testimonials and photos. Posting more on facebook was a priority. Mick asked if we can use the user's photos for our publicity purposes. We can if we get permission from the photo creator with credit. April 23 is Rails to Trails National Trails Day. The first weekend in June is National Trails Weekend.

The Government Relations Committee met a few weeks ago. There was discussion if there needs to be a hearing at the State Legislature in order for bill concerning the Casey Jones Trail to be pushed through. Dan asked Senator Weber to contact him concerning this question. Myron mentioned that we could possibly go through DEED to get funding for the trail.

The Fundraising Committee has not met. The committee needs to work on getting large funds to use towards trail development or grant funds matching. Jakob mentioned that the Friends group ran a loss financially in 2022. The group isn't in immediate trouble but does need to do something moving forward. Myron mentioned that he has been working with a group of SW MN Mayors. He would recommend that the Casey Jones present to this group in the future.

# Parks and Trail Grants: Seed Collection and Earth Day

Jakob reported that we have received \$950 in grant funds from the Parks and Trail Council of MN. \$800 is for a seed collection project with the DNR in the fall and \$150 is for a coordination of a Earth Day Clean Up event on the Lake Wilson section on April 23. The DNR is requiring that volunteers for this event sign up for a background check and prove COVID vaccine status. The Friends group officers have written a letter to the DNR Commissioner to express their disagreement with the stringent requirements for volunteering.

# **DNR** Updates

Chris provided an update from DNR. They are looking for summer help at Split Rock Creek State Park. Mick asked about planting trees at the Pipestone Trail head. Chis will look into it.

#### Other

We will discuss the annual meeting details at the next meeting.
